## Sublease Instructions

The attached sublease is provided by the Boone Tenants Association in the Student Center. Use one sublease form per subleaser. Fill out the sublease, making sure your subleaser provides his/her name, permanent address and cell number at the bottom.

**RENT PAYMENT**: Continue paying rent to us and have your subleaser pay you, so you know he/she has paid. Remember, you already paid July rent last year when you paid August rent, so you will need to collect July rent from your subleaser.

**SECURITY DEPOSIT**: Take a security deposit, especially if you are not coming back at the end of your lease to clean. Please print for your subleaser the cleaning checklist and move-out instructions provided as a link on the Tenant Info page of www.denice.com.

**UTILITIES**: Discuss utilities with your subleaser. Coordinate with subleaser and with utilities companies the shut off and turn on date so as not to disrupt services. Utilities numbers: City of Columbia Water & Light, 573-874-7380; Ameren (hot water and furnace), 800-552-7583.

**TRASH**: Tell subleasers about trash. Summer trash collection in East Campus is early Monday mornings. If you have a trash bin, you must roll it to the curb on Sunday evening and roll it back to the building by Monday afternoon or incur a trash service fee of up to \$40 per week.

**ROOMMATES' CONSENT**: All original residents on the lease must sign the sublease giving permission for the subleaser to sublease. This ensures everyone agrees to the sublease arrangements. See signature lines on item #7 of the sublease agreement.

**SUBLEASE TO LANDLORD**: Give a copy of your original lease to the subleaser, make copies of the sublease for yourself and your subleaser, then turn in the original. We will attach the sublease to the original lease.
